CASE COORDINATION PROGRAM - CHICAGOCAC COORDINATED 2,231 MULTIDISCIPLINARY INVESTIGATIONS INTO REPORTS OF CHILD SEXUAL ABUSE AND 216 MULTIDISCIPLINARY INVESTIGATIONS INTO REPORTS OF SEVERE CHILD PHYSICAL ABUSE. 1,601 FORENSIC INTERVIEWS WERE PERFORMED. INVESTIGATIONS OFTEN REQUIRE CHILDREN TO BE INTERVIEWED ABOUT THE INCIDENT OF ABUSE AND SOMETIMES CHILDREN RECEIVE A FORENSIC MEDICAL EXAM.
