TWO STAFF MEMBERS VISITED THE STATE CAPITOL IN FEBRUARY 2020 TO PROMOTE CACS AND THE ORGANIZATION'S LEGISLATIVE AGENDA AND ONE MET WITH A LEGISLATOR. STAFF MEMBERS MET VIRTUALLY WITH LEGISLATORS IN MAY 2020 TO PROMOTE MORE FUNDING FOR CACS LEADING UP TO A SHORT SPECIAL SESSION OF THE LEGISLATURE AT THE END OF MAY.

IN JANUARY 2020, ONE STAFF MEMBER TESTIFIED ON CAPITOL HILL IN WASHINGTON, DC AND MET WITH FEDERAL CONGRESSPEOPLE REGARDING SEXUAL ABUSE PREVENTION EDUCATION. ONE STAFF MEMBER MET WITH STAFF MEMBERS FOR THREE REPRESENTATIVES AND ONE SENATOR FROM ILLINOIS. THE PURPOSE OF THESE MEETINGS WAS TO PROVIDE GENERAL INFORMATION ABOUT CHICAGOCAC AND ITS ACTIVITIES AS WELL AS TO REQUEST SUPPORT OF THE FEDERAL POLICIES DESCRIBED BELOW. THE NATIONAL CHILDREN'S ALLIANCES' ANNUAL HILL DAY IN WASHINGTON, DC IN JUNE 2020 WAS POSTPONED DUE TO THE COVID19 PANDEMIC AND OCCURRED IN A VIRTUAL SETTING FY2021.
